



A breakdown of our event attendees and their budgets and key priorities.




ANNUAL COMPANY TURNOVER SUMMARY


PERSONAL BUDGET RESPONSIBILITY SUMMARY

Session Summaries - Day 1




The Most Influential Tech Trends that will Impact the Safety Profession

Taking Hand Protection Deeper

The safety industry has undergone some impressive changes. Organisations are unsatisfied with where minimum compliance has led them. This plateau of improvement requires safety professionals to push beyond minimums to look for new solutions to age old problems.

Protecting worksite employees from avoidable injuries has become increasingly important as incident reporting becomes more publicly transparent and top management continues to drive towards target zero. HSE managers weigh the price of quality PPE with the potential costs of workers comp claims as they attempt to satisfy increasingly aggressive accounting constraints. As safety managers work to orchestrate high participation safety programs, they are often overwhelmed by both the explosion of new safety products on the market today and the lack of resources to plan, implement, and sustain changes that matter.

Creating a Safety Culture Through Positive Observations

Typically, when we observe, measure and track safety performance we're focusing on what's going wrong. In recent years, Balfour Beatty has discovered that when their teams take the time to recognize what's going right and reward good safety behaviours they begin to shift the mentality and attitude on safety.

"When positive reinforcement is combined with superintendent leadership and best practices, like pre-task planning, we not only shift the culture of safety we eliminate risks from our projects altogether." In this workshop, Chris shared recent examples of a process that is changing the culture of safety at Balfour Beatty.



Advanced Human and Organizational Performance - How Personality Impacts Managing Risk

This interactive session from Ray of Fisher Improvement Technologies touched on the most advanced science-based information and methods related to HOP and the importance of understanding personality tendencies when managing risk.

Different people with different personality tendencies see and manage risk differently. This session introduced attendees to the concepts of how to understand the differences at all levels of the organization to better manage risk and reduce incidents. Attendees were encouraged to download the "E-Colors" App onto their mobile phone before the session and take the Personality Diversity Indicator (PDI) to determine their personality tendencies so that they could get the most out of the workshop.

DONNA MCENTEE Workplace Safety and Health Solution Manager, Skillsoft

Safety and Health Learning Program ROI Methodology

Determining the Return on Investment for your safety and health learning program can be quite challenging. Building a credible process to evaluate key measurable aspects of your program requires careful thought and consideration. The benefits of conducting an ROI include showing the contribution your program makes to the organization versus the cost (justifying the cost of your training program), demonstrates the value safety and health training provides to the overall success of the organization, and, provides a tool for identifying both useful and ineffective programs or areas in need of improvement.

In this session, Donna explored ROI models, and the process of capturing and evaluating data, and communicating results.



Driving Mental Health Strategies

The wellbeing and mental health of the employees in the workplace is becoming a key element of the work relationship between employees and employers. Employees are keener to work with employers able to provide a work environment where mental health support can be provided to the employees with relevant employees assistance programs.



The Evolution of Wearables and Its Advancements into the Workplace

Wearables in the workplace is a hot topic, but what difference can they make to your workplace safety culture? How do you identify risk, design it out, measure and improve?

Traditional ergonomic workplace assessments are subjective and don't paint a full picture of the movement strain being placed on individuals. However, with detailed and objective data, organizations can make fully informed decisions with confidence.

In this workshop attendee's learnt how wearable sensor technology is being used by leading businesses globally to identify movement risk, make manual handling policy decisions, develop and execute effective manual handling training programs, and to inform and guide equipment selection, manage onsite and interactive training programs and change manual handling movement behaviour.



Chemical Inventory Process Improvement

Fruit of the Loom, Inc. needed a database system that could consolidate chemical inventories from over 30 facilities; track chemical approval processes; provide chemical component listings and handle safety data sheets revisions and updates.

Consolidating chemicals between facilities and handling safety data sheet revision updates is very difficult and time consuming. Fruit of the Loom was searching for a system that would allow them to share their chemical inventories across all divisions and assist in compliance with OSHA Hazard Communication standard, EPA reporting and customer requirements.

This workshop showed how they were able to implement a database management system that consolidates all their facility inventories; handles revisions and updates; streamlines their approval process; reduces their overall chemical inventory by 20%; complies with reporting regulations worldwide and simplifies their process to answer customer inquiries.



Transforming the Enterprise - Building a Center of Excellence for EHS and Fleet Excellence

This session described CHS's journey of creating collaboration of EHS leaders into their Business Units to drive EHS and fleet transformation. This session highlighted methods these teams used to improve EHS and fleet systems and create a sustainable EHS and fleet management system for the organization for years to come.



The Past the Present and Now – Setting Ourselves up as the Next Generation Safety Leaders

This panel discussion from a range of industry experts explored the ever-changing dynamics in the role of a health and safety leader from where it was to where it is today and how to prepare for the future of the role as a safety leader.

Integration of Workers Compensation and EHS

Various theories and research findings were presented to begin a discussion on what this means for safety professionals. Session Summaries - Day 2



The Curious World of Safety

Safety has traditionally been about the elimination of negative outcomes (incidents, injuries, errors, malfunctions). While this approach has led to significant improvements it has also produced several problematic side effects: disengagement and disempowerment of people, increasing bureaucracy, loss of innovation and productivity. Furthermore, many organisations now struggle with plateauing safety records. Some industries even experience increasing injury and fatality rates despite unprecedented investments in safety.

Over the last 5 years, a growing number of organisations and thought-leaders have developed a set of ideas and practices that help organisations to overcome the current impasse.

This session explored the required changes to what safety leaders do and how it's done as HS practitioners as well as the shifts in skills and competencies that are needed to make this paradigm change happen.

Making Mental Health Matter – An Enterprise Experience

Mental health concerns are an emerging risk that drive all key performance metrics, including safety. Developing a strategy to address these concerns in the workplace and normalizing conversations around the subject to reduce the associated stigma are paramount to building a culture of caring throughout the organization.

Discussions during this workshop included highlights of the Jacobs Global strategy to improving the overall good health and well being in the organization.





WORKSHOP

RAY FISHER Advanced Error Reduction and Training Manager, Fisher Improvement Technologies

Effective Engagement - Moving from Empowering to Enabling

This workshop allowed attendee's to learn from a pioneer in human and organizational performance how incorporating personality diversity into how people see and manage risk helps move people from simply being empowered to stop work and get help, to enabling them to effectively engage in a way to prevent errors and incidents.

Effective engagement and enabling also drive better use of near-miss and near-hit reporting and analysis. Using the lessons learned from engaging the volunteers for Superbowl 51, Ray provided an 'intentional communications' tool that everyone who attended will now have the ability to use.



Turning Conventional Continuous Improvement Processes Upside-Down Through Positive Work

This workshop explored a case study on a corporate program called +Projects where:

- Successful work is defined and recognized based on all factors of success (e.g., scope, schedule, budget, safety);
- You can determine why success has occurred through a causal analysis;
- Establishing what positive actions need repeated across the company to assure success is repeated by choice, not chance.



Hybrid Behavior Based Safety Program

This session reviewed Ports America's safety program, SAFE PORTS. A "hybrid behavior based" safety program that has become a very potent tool to effect post-merger integration in various marine terminal organizations and most specifically, Ports America Inc. There is a saying in the Maritime Industry that "when you've seen one port, you've seen one port – no two ports are alike".

SAFE PORTS has been used to not only position Ports America, an organization that operates 80 marine terminals in 50 ports along the 3 coasts of United States, as a leader in safety in the Maritime Industry, but has produced extra ordinary results in the alignment of the subcultures within this organization that became the largest marine terminal operator following the merger of multiple legacy companies.

It's Fatal 5 Program prevents fatalities; It's Roadmaps Program outlines a systems approach towards safety excellence; Its GAP Analysis and Peer Review Programs identify weakened defenses and recommends corrective actions proactively; and Its Walkabout Program encourages the elimination of unsafe behavior, mentoring and coaching.





ROUNDTABLE DISCUSSION

JOHN PACE Director – Safety and Health, Bridgestone HosePower

Risk Assessment; Best Practices and an Overview of the Bridgestone Safety Philosophy

This session covered an overview of Bridgestone's safety fundamentals global management system, and some general examples of the businesses mission to serve society with superior quality. It also covered Bridgestone HosePower's operations and how risk assessment influenced their original equipment manufacturing, mobile service, and service branch operations.

To serve the intent of the breakout session and promote interactive discussions, John then solicited examples of best practices from the group, and offered insight to those who inquired if principles of the Bridgestone Way could be applied to their own company.



Influencing Skills for HSE Professionals

In today's challenging environment, health and safety professionals have the skills to implement management systems, but many lack the skills to convince Sr. Management to take the lead or approve critical programs.

This roundtable was host to an open discussion on various techniques on how to influence and persuade people.

Some of the techniques discussed may have been found as ethically and morally questionable, but it is important to know and understand them so they will not be used by others to influence you. Participants needed to understand that there are many more techniques than what were discussed, but the techniques that were discussed are some of the most commonly used.



Leadership for Today's 24/7 Safety Problems

Since the vast majority of injuries and accidental deaths occur outside the workplace, many organizations are trying to determine how their current safety management system will protect their employees 24/7. For most companies, the cost of off-the-job injuries is higher than on the job, and command and control strategies have had little positive effect.

Employees need to be introduced to practical tools that can be used every day to reduce injuries both on and off the job.

This session explored how you can recognize the repeated critical errors that are made in virtually all injuries and drastically reduce injuries 24/7.



Working in a Distracted World

As you start another day at work, are you excited to see what you can get completed? If not, what is holding you back? Are you stressed? Is your plate overflowing with work you have yet to start? Between work assignments, meetings, emails, family issues, social media, and the current political climate, it is a wonder that any of us get anything completed. What is more concerning is that what work we complete usually lacks the professional quality we expect. At this point you may feel that there is no way to overcome this challenge, but you would be wrong. This presentation provided techniques to accomplish more while working in a distracted world.



Safety Culture Action Enabled Strategy

Fred held the closing keynote presentation where he spoke about safety culture and action enabling strategies to create a safe workplace including the safety responsibilities of all business parts.
